3. PERFORMANCE TEST (PT): THIS SECTION EVALUATES A CANDIDATE'S PRACTICAL SKILLS BY REQUIRING THEM TO COMPLETE A LEGAL TASK, SUCH AS DRAFTING A MEMORANDUM OR BRIEF BASED ON A PROVIDED SET OF FACTS AND LEGAL PRINCIPLES.

ELIGIBILITY REQUIREMENTS

TO SIT FOR THE CONNECTICUT BAR EXAM, CANDIDATES MUST MEET SEVERAL ELIGIBILITY CRITERIA:

- GRADUATED FROM AN ABA-ACCREDITED LAW SCHOOL
- COMPLETED THE REQUIRED COURSEWORK
