CANDIDATES ARE REQUIRED TO PASS ALL FOUR SECTIONS WITHIN AN 18-MONTH PERIOD, STARTING FROM THE DATE OF THE FIRST PASSED SECTION. THE CPA EXAM IS COMPUTER-BASED AND IS OFFERED AT PROMETRIC TESTING CENTERS ACROSS THE UNITED STATES.

STRUCTURE OF EACH SECTION

EACH SECTION OF THE CPA EXAM HAS A SPECIFIC STRUCTURE, WHICH INCLUDES A COMBINATION OF MULTIPLE-CHOICE QUESTIONS, TASK-BASED SIMULATIONS, AND WRITTEN COMMUNICATION TASKS.

1. AUDITING AND ATTESTATION (AUD)

- CONTENT AREAS:
 - PLANNING THE AUDIT
 - PERFORMING AUDIT PROCEDURES

 - THE AUD SECTION IS SCORED ON A SCALE FROM 0 TO 99, WITH A PASSING SCORE SET AT 75.

2. BUSINESS ENVIRONMENT AND CONCEPTS (BEC)

- CONTENT AREAS:
 - CORPORATE GOVERNANCE
 - ECONOMIC CONCEPTS AND ANALYSIS
 - FINANCIAL MANAGEMENT

- INFORMATION TECHNOLOGY
- OPERATIONS MANAGEMENT
- FORMAT:
 - 62 MULTIPLE-CHOICE QUESTIONS (MCQs)
 - 4 TASK-BASED SIMULATIONS (TBS)
 - 3 WRITTEN COMMUNICATION TASKS (WCT)
- SCORING:
 - LIKE THE AUD SECTION, BEC IS SCORED ON A SCALE FROM 0 TO 99, WITH A PASSING SCORE OF 75.

3. FINANCIAL ACCOUNTING AND REPORTING (FAR)

- CONTENT AREAS:
 - CONCEPTUAL FRAMEWORK, STANDARD-SETTING, AND FINANCIAL REPORTING
 - FINANCIAL STATEMENT ACCOUNTS
 - TRANSACTIONS
 - STATE AND LOCAL GOVERNMENTS
- FORMAT:
 - 66 MULTIPLE-CHOICE QUESTIONS (MCQs)
 - 8 TASK-BASED SIMULATIONS (TBS)
- SCORING:
 - THE FAR SECTION IS SIMILARLY SCORED ON A SCALE FROM 0 TO 99, WITH A PASSING SCORE OF 75.

4. REGULATION (REG)

- CONTENT AREAS:
 - ETHICS AND PROFESSIONAL RESPONSIBILITY
 - BUSINESS LAW
 - FEDERAL TAXATION OF INDIVIDUALS
 - FEDERAL TAXATION OF ENTITIES
- FORMAT:
 - 76 MULTIPLE-CHOICE QUESTIONS (MCQs)
 - 8 TASK-BASED SIMULATIONS (TBS)
- SCORING:
 - THE REG SECTION IS SCORED ON THE SAME 0 TO 99 SCALE, REQUIRING A MINIMUM SCORE OF 75 FOR PASSING.

EXAM SCHEDULING AND ADMINISTRATION

THE CPA EXAM IS AVAILABLE YEAR-ROUND, ALLOWING CANDIDATES FLEXIBILITY IN SCHEDULING THEIR TEST DATES. THE EXAM IS DIVIDED INTO TESTING WINDOWS:

- TESTING WINDOWS:
 - JANUARY TO MARCH
 - APRIL TO JUNE
 - JULY TO SEPTEMBER
 - OCTOBER TO DECEMBER

CANDIDATES CAN TAKE EACH SECTION OF THE EXAM DURING THESE WINDOWS, BUT THEY MUST ADHERE TO THE 18-MONTH RULE

FOR PASSING ALL FOUR SECTIONS.

SCORING AND RESULTS

THE CPA EXAM EMPLOYS A SCALED SCORING SYSTEM, MEANING THAT RAW SCORES ARE CONVERTED TO A COMMON SCALE TO ACCOUNT FOR VARIATIONS IN DIFFICULTY ACROSS DIFFERENT EXAM VERSIONS. THE MINIMUM PASSING SCORE FOR EACH SECTION IS 75. RESULTS ARE TYPICALLY RELEASED WITHIN A FEW DAYS TO A WEEK AFTER THE EXAM IS TAKEN, DEPENDING ON THE SECTION.

PREPARATION STRATEGIES

SUCCESSFULLY PASSING THE CPA EXAM REQUIRES THOROUGH PREPARATION. HERE ARE SOME STRATEGIES TO HELP CANDIDATES GET READY:

1. UNDERSTAND THE CONTENT OUTLINE

FAMILIARIZE YOURSELF WITH THE AICPA'S CONTENT SPECIFICATION OUTLINE (CSO) FOR EACH SECTION. THIS DOCUMENT OUTLINES THE KNOWLEDGE AND SKILLS TESTED IN EACH PART OF THE EXAM.

2. CREATE A STUDY PLAN

DEVELOP A STRUCTURED STUDY SCHEDULE THAT ALLOCATES TIME FOR EACH SECTION BASED ON YOUR STRENGTHS AND WEAKNESSES. A WELL-ORGANIZED STUDY PLAN CAN HELP ENSURE COMPREHENSIVE COVERAGE OF ALL TOPICS.

3. UTILIZE REVIEW COURSES

CONSIDER ENROLLING IN CPA REVIEW COURSES THAT OFFER STUDY MATERIALS, PRACTICE EXAMS, AND PERSONALIZED COACHING. THESE RESOURCES CAN PROVIDE GUIDANCE AND STRUCTURE TO YOUR PREPARATION.

4. TAKE PRACTICE EXAMS

REGULAR PRACTICE EXAMS CAN HELP GAUGE YOUR READINESS. THEY ALSO FAMILIARIZE YOU WITH THE EXAM FORMAT AND TIMING, REDUCING ANXIETY ON TEST DAY.

5. JOIN STUDY GROUPS

ENGAGING WITH PEERS IN STUDY GROUPS CAN ENHANCE UNDERSTANDING AND RETENTION OF COMPLEX TOPICS. GROUP DISCUSSIONS OFTEN LEAD TO NEW INSIGHTS AND STUDY TECHNIQUES.

WHAT IS THE STRUCTURE OF THE CPA EXAM IN 2023?

THE CPA EXAM IN 2023 CONSISTS OF FOUR SECTIONS: AUDITING AND ATTESTATION (AUD), BUSINESS ENVIRONMENT AND CONCEPTS (BEC), FINANCIAL ACCOUNTING AND REPORTING (FAR), AND REGULATION (REG). EACH SECTION IS INDEPENDENT AND CAN BE TAKEN IN ANY ORDER.
