LEGAL FRAMEWORKS ADDRESSING HOLOCAUST DENIAL

SEVERAL COUNTRIES HAVE IMPLEMENTED LAWS TO CRIMINALIZE HOLOCAUST DENIAL, VIEWING IT AS A FORM OF HATE SPEECH AND INCITEMENT TO RACIAL HATRED.
